for KZED Public Media

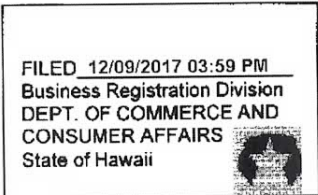
The undersigned, desiring to form a Non-Profit Association under the laws of the State of Hawaii do hereby certify:

1. The name of the Association shall be KZED Public Media.
2. KZED Public Media is a Nonprofit Association recognized under Hawai'i Revised Statutes Chapter 429 ("HRS 429").
3. The association is nonprofit in nature and shall not authorize or issue shares of stock. No dividends shall be paid and no part of the income or profit of the association shall be distributed to its members, directors, or officers, except for services actually rendered to the association.
4. The initial members joined by mutual consent for the common, nonprofit purpose as defined by HRS 429 are: KZED Inc. and KQHW Inc.
5. For purposes of Venue as defined by HRS 429, the nonprofit association has it's initial office in Mountain View, HI. The initial mailing address of the association is PO Box 711531, Mountain View, HI 96771.
6. In an action or proceeding against KZED Public Media, a summons and complaint shall be served on KZED Inc. who is authorized to participate in the management of KZED Public Media's affairs. The name of the current registered agent for KZED Inc. is on file with the State Of Hawaii Department Of Commerce And Consumer Affairs Business Registration Division (or successor division).
7. Upon the dissolution of the association, assets shall be distributed in compliance with HRS 429 to KZED, Inc. The inactivity period in §429-9 of HRS 429 shall be 6 months. Assets shall be used for noncommercial purposes.
